## **ABSTRACT**

That the main problem of this research is the Review of Islamic Law on the Fulfillment of Birth and Inner Livelihood in elderly marriages in Wonoploso Village, Gondang District, Mojokerto Regency. Aims to find out: (1) How to fulfill physical and spiritual living in elderly marriages in Wonoploso Village, Gondang District, Mojokerto Regency. (2) How is the review of Islamic law on the fulfillment of physical and spiritual living in elderly marriages in Wonoploso Village, Gondang District, Mojokerto Regency. This method uses field research (field research). This approach is descriptive analysis, with direct reference to elderly married couples.

The results of this study indicate one couple who carries out an elderly marriage and the marriage is carried out according to Islamic law. So that the husband's responsibility towards his wife (subsistence), which results in the wife being unable to sue her husband. Broadly speaking, there are outward and inner livelihoods that are fulfilled, although not optimally due to the age factor, while

inner livelihoods are not fulfilled. This is very clearly seen because in elderly marriages they are relatively old and no longer productive.

While in the review in Islamic law that the husband is obliged to provide a living for his wife, both physically and mentally. Islamic law has contained several rules and responsibilities of the husband, which aims to avoid the possibility of harm to women.

The fulfillment of a living that occurs in Wonoploso Village, Gondang District, Mojokerto Regency can be tolerated on the grounds that the provisions in Islamic law and the Compilation of Islamic Law (KHI) do not regulate the size of the fulfillment of a living, it is only said to be adjusted to each individual's ability. As long as it does not cause harm, and there is no element of persecution and is carried out on the basis of the awareness and willingness of couples who marry at an advanced age, this willingness can be seen when the consent is qabul.
